

COMPTON NEIGHBOURHOOD DEVELOPMENT PLAN (NDP) UPDATE - JUNE 20

Our last update reported that producing a Neighbourhood Development Plan was never going to be a quick process.

Even under perfect conditions there are all kinds of checks and balances that need to be undertaken when preparing a statutory document. If you then throw in a general election followed by a global pandemic – understandably neither of which were on our radar when we began this process in 2018! – it has certainly added time to the process.

However, rest assured the Compton NDP team are continuing to work remotely and meeting on a regular basis electronically via Zoom.

Alongside our consultants Aaron Smith and Hollie Snyder from Fowler Architecture and Planning we are currently amending and adding to the first NDP draft.

The second draft should be in our hands by the end of May and once agreed, after further scrutiny, will be shared with the Parish Council (PC) and West Berkshire District Council (WBDC) in a consultation exercise. The objective here is to ensure that the NDP's general direction of travel meets with approval.

As previously reported, the NDP team was delighted by the attendance and interest shown at the two NDP Village Hall presentations focusing on the Pirbright site held on February 13 and many thanks to all of you who participated. Your input has been invaluable.

The completed questionnaires have been analysed and important trends and concerns identified. It is clear, there is little support for Homes England's proposed number of houses to be developed on the Pirbright site.

Homes England's Imminent Pirbright Planning Application

We expect Homes England to lodge its outline planning application with WBDC soon. As identified by the department earlier in the year we expect it to be a plan of approximately 250 houses.

You will know that the NDP is proposing a mixed development of approximately 140 houses, including employment, business and green space – this was published in our Interim Policy Statement on Pirbright (September 2019). This size and type of development was also recommended in WBDC's Pirbright Special Planning Document (September 2013). Both can be found on our website.

When Homes England's planning application is lodged it will be published on the Council's webpage https://publicaccess.westberks.gov.uk/online-applications/search.

You will have the chance to submit comments within a set timeframe and this can be done in one of three ways

In this way the village will clearly be making its reaction public.

Once the application is lodged, the NDP will make an immediate village leaflet drop to confirm the application reference number, a reminder of how to comment and closing date.
